Regular Meeting – 9:00 a.m.

Regular Meeting: The Converse County Justice Center Joint Powers Board meeting was called to order at 9:00 a.m. by Chair Rick Grant with the following members also present: Ron McNare, Mike Colling, Terry Moss, Kim Pexton and Perry Hershberger. With apologies, Robert Short was absent. Mr. Grant led the Pledge of Allegiance.

Mr. Grant called for a motion to approve the regular minutes from the June 15, 2023, meeting. Mr. Moss moved to approve the regular minutes of June 15, 2023, Mr. Colling seconded, all members voting aye, motion carried.

There was discussion on the Communication invoices. Mr. Grant called for a motion to approve the Communications invoices. Ms. Pexton made a motion to approve the June Communications invoices; Mr. McNare seconded, all members voting aye, motion carried.

There was discussion on the Operations invoices. Mr. Grant called for a motion to approve the Operations invoices. Mr. McNare made a motion to approve the July Operations invoices; Mr. Hershberger seconded; all members voting aye; motion carried.

Captain Adam Alvarado stated the last Advisory Committee meeting was on July 12, 2023. There was discussion from DPD regarding Superuser permissions, CCSO provided a relevant State Statute for further discussion. DPD requested a TAC channel for Probation; there was general radio upgrade discussion. IT provided voicemail instructions, EMD software is installed and Eventide is operational. Ambulance service to Glenrock and response to the Antelope Mine was discussed and the next meeting date is August 9, 2023.


Alex Boespflug, Dispatch Supervisor, provided staffing and training updates for Dispatch. Mr. Boespflug provided updates for the EMD Shareholder meeting and the last Dispatch meeting, held on July 14, 2023. Mr. Boespflug stated Dispatch will have a booth at this year's State Fair with DPD and Fire, working on improving Social Media communications and currently working on update local business contacts. Undersheriff Nate Hughes discussed the issues he's working through with DigiTicket.

Chris Caskey, Technical Services Director, discussed the irrigation system at the Justice Center; it was turned on last week and maintenance performed. Mr. Caskey stated the vending machine has been removed, Black Hills Energy credits are complete and were credited last month, and Johnson Control repaired the heating issue in the Sally Port. There was discussion on the janitorial services.


Next meeting: The next regular meeting has been scheduled for August 17, 2023, at 9:00 a.m. in the Commissioners' Chambers of the County Courthouse.
