

**CONVERSE COUNTY, WYOMING

House Bill 54, passed by the 65th Wyoming State Legislature in early 2019, provides funding for counties to develop or revise county natural resource management plans. County natural resource plans are, per House Bill 54, to serve as a basis for communicating and coordinating with the federal government and its agencies on land and natural resource management issues. A steering committee is being formed to assist with the development of the Converse County Natural Resource Plan.

- Members must be residents of Converse County, or represent a business or entity doing business in Converse County with significant activity associated with the categories listed below.
- Members of this steering committee can expect a minimum of a two-year commitment with approximately six (6) meetings per year along with monthly conference calls/virtual calls.
- Members are expected to attend all Steering Committee meetings.
- Members are encouraged to seek additional individuals with professional expertise associated with their area of responsibility.
- Members of this committee will serve through the completion of the document
